## Directions

**PREPARATION:** Strip other polishes from the floor with HILLYARD GREEN SELECT STRIPPER, SUPER STRIP or DEVASTATOR. (Do not use abrasive pads on tile containing asbestos.) Remove the stripping solution with a wet vac. Rinse with HILLYARD NUTRA-RINSE solution and pick up with a wet vac or autoscrubber. Damp mop twice. Allow floor to dry.

**APPLICATION:** Using a clean synthetic mop, apply 3 coats of ONE PLUS allowing a minimum of 30 minutes between coats. Additional coats of ONE PLUS may be applied, provided adequate dry time (at least one hour) is allowed between coats. Temperature, humidity, and air movement affect curing time.

**NOTICE:** ONE PLUS can be used as its own seal even on porous floors. Proper drying between coats prevents pulling or streaking with any polish. For best results, allow 30 minutes drying time between coats.

**NOTE:** Do not pour unused polish back into container. Best results are obtained with adequate ventilation and floor temperatures above 60°F (16°C).

**High Speed Burnishing:** Because high speed burnishing is affected by many variables, including equipment type, pad pressure, frequency of burnishing, and traffic loads contact Hill-yard Technical Service for pad recommendations.
